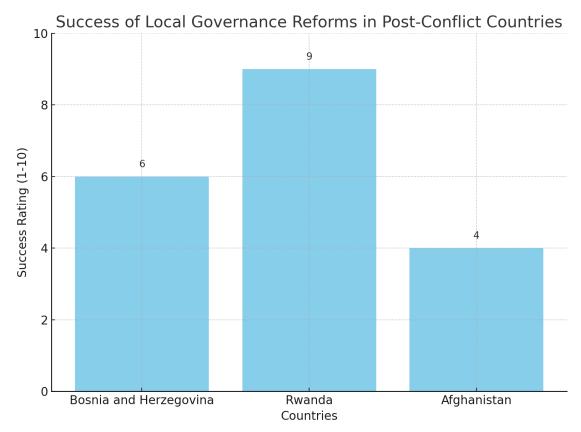


Figure 1. Success of Local Governance Reforms in Post-Conflict Countries
